Bookings must be made with payment in advance of the conference. Payment can be made by using either of the following methods:

The form should be completed and returned to Valerie Kelley (address as below), together with a cheque or banker's draft drawn up in Pounds Sterling for the appropriate amount (see below) and made payable to **Birkbeck**.
